Challenge Corner

Survivor 2007 – First Round

As Ryan Seacrest would say, "The results are in!" On March 30th, the challenge of Survivor 2007 began at Hansen Dam. The weather was ideal, the greens were lightning fast, and the team of Jeff Shoji and Rich Tsuchida just smoked the other 14 teams. Their team net score was 145, compared to the first runner-ups (following a tie breaker), Victor Vannukul and Michael Yi who finished with a net 152. These two teams earned an exemption from elimination at the next Survivor venue (Balboa Course – Sepulveda Golf Complex), on May 11th. The beautiful day was spoiled by a distant plume of smoke. Some people thought it was the "Barham-Forest Lawn fire", actually it was the wheels coming off Rick Sackett's game (13 strokes over par on the last 5 holes).

With two teams exempt, the remaining 13 teams will be vying for the 6 available Survivor spots. The combined net scores from Hansen Dam and Balboa will be used to determine the survivors. Knollwood Country Club will be the site of the third round of Survivor 2007 on Friday, July 13th. The locations for the fourth and the fifth (final) rounds have not been set yet.
