It had such a warm reception, that we voted to have the event every other year, alternating with the ALSRI Cup years. The format for the Survivor Cup, is that you pick a partner, someone who wants to be your partner.

The only requirement is that all of the participants must be ALSRI members, and they must have an established SCGA handicap. The field of participants from 2001, was limited to 32 players (16 teams). Since our membership has grown. we would like to accommodate more teams initially. The operative word here is initially! The first elimination is scheduled for March 14th, at Los Serranos (North).

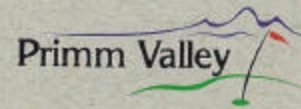
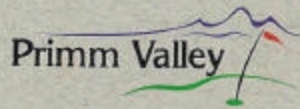
