I was wondering if I had a electronic rangefinder, could I use it at the next ALSRI Tournament at Trilogy, and can any one of my foursome also use it, if it is stuck to my bag and they knew where it was?

**Ask ALSRI** Answer:

As of 01/01/06, the **USGA** allows the use of distance measuring devices in tournament play under local rules. Its covered under **Rule 14-3/0.5**. Distance measuring devices (that **do not** include features that measure wind, or gradient) will be allowed in **ALSRI** tournaments this year.

Regarding the second part of your inquiry, the device can only be used by its owner. As an analogy, its like borrowing one of your foursome's golf clubs for use during a tournament, which clearly is not allowed under the Rules of Golf. So, if the other members of your foursome want to use a measuring device, they've got to get their own.
