The first two **Survivor 2007** events are already scheduled; the format of each event will be announced later. The first one will be at **Hansen Dam** on **March 30th**. The second one, if you and your partner survive will be at the Sepulveda Golf Complex - **Balboa Course** on **May 11th**. The **ALSRI Board** members met last month. Listed below are some of the items that came out of that meeting:

1. **Tournament Fee increase:**

The **Board** approved a **\$3 per player** fee increase (total tournament fees will now be **\$8** above cost per player), beginning with the **Los Serranos Tournament in April**. **Note** that this is the first fee increase in the **ALSRI's 16 year history**. Its needed to absorb increased membership operational costs and to account for inflation.

2. **June Tournament update:**

We will be replacing **Primm** with a golf/hotel venue in **Henderson, NV**, which is approximately **15 minutes** from the **Las Vegas Strip**. The golf tournament will be played at the **Anthem Revere GC**. There are **two courses** we will play at this property, the **Lexington GC** and the **Concord GC**. Both are comparable to the courses we played at **Primm**.

The hotel accommodations are being finalized. We plan to stay at one of the **Station Casino / Hotel** properties, the **Fiesta Henderson**. Because of the change in venue, we had to change the dates of this year's event. It will be held on **June 07 thru 10, 2007**. Stay tuned to our Newsletter in the coming months! We are working on some very exciting possibilities for our **2008 June event**.
